(\*) Subsystems and safety components which are in conformity with harmonised standards or parts thereof the references of which have been published in the Official Journal of the European Union shall be presumed to be in conformity with the essential requirements set out in Annex II Regulation (EU) 2016/425.

**Validity conditions:** This certificate is valid for 5 years from the date of issue. On expiration the manufacturer shall ask for its renewal. The rules applied are those in force on the date of issue shown on this certificate; The validity of the certificate is no longer guaranteed if substitutive standards are issued before the expiration date. All changes made to the model and to the materials described in this EU type-examination certificate shall be reported to and approved by CIMAC. This EC Type-Examination Certificate may be integrally duplicated; the copy must be faithful, legible (if pint size) and must contain the bold caption "TRUE COPY". This certificate must be kept by the manufacturer to be shown, on request, to the inspection or notifying authorities.
