Jacket with high collar with hood closed by frog and hook and loop tape united to collar by snaps. Round sleeves with cuff closed by frog. Central opening closed by zipper covered by flap closed by hook and loop tape.

Two horizontal pockets on chest covered closed by zipper and two expandable pockets frontside covered by flap closed by hook and loop tape. Two welt pocket on hips closed by zipper and one waist belt, with black reinforcement on elbows and retroreflective inserts material on arms, right's chest and back.

100% PL, 200 g/m² art.300Dx300D.

Net lining:

100% PES – 55 g/m²

Inner lining:

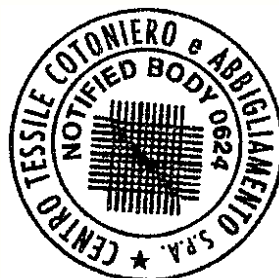
